Most of Lighthouse Guild International's services are provided with and through these affiliate corporations. The Jewish Guild for the Blind d/b/a Jewish Guild Healthcare, Lighthouse International, GuildNet, Inc, JGB Health Facilities Corporation, JGB Rehabilitation Corporation, JGB Education Services, JGB Mental Health and Mental Retardation Services, Inc, National Association of Parents of Children with Visual Impairments, Inc, Greater Boston Guild for the Blind, Inc, and Greater Boston Diabetes Society. In addition to services for blind and visually impaired children and adults, low-vision rehabilitation programs train healthcare professionals to identify functional vision problems, address vision issues in the healthcare setting, and refer patients to low-vision services. Training is offered in a variety of formats, including workshops, online continuing education courses, webinars, instructional DVDs, and printed materials
