VI.11 b - The board received form 990 by email and then voted on approving its submission on 22 January 2016.

VI.12.c - The conflict of interest policy was reviewed by the board at inception and then annually each January.

Each board member signed a statement of adherence to the policy in January 2016.

VI.19 - The by laws, conflict of interest policy, financial statements, & form 990 were posted on the web in Jan 2016 for the preceding year.
