OneReef has signed a Memorandum of Understanding with Palau's Environment Ministry to develop a sustainable financing plan for Palau's conservation network We support Palau in implementing its commitment to the Micronesia Challenge, protecting 30% of the marine environment and 20% of terrestrial environment by 2020 Our site-based model of conservation combines public funding from Palau's tourism fees (\$4.5m collected annually) and private funding from global partners Our existing model is becoming nationally relevant through this novel public-private partnership, with international implications as we continue to grow our portfolio across the Micronesia Region

OneReef is replicating our model across the Asia-Pacific by working with more than ten engaged communities that want to protect their reefs and see our proven success We have trial agreements with five communities and are in process of developing long-term agreements with five more, to more than triple the size of our portfolio and reef area protected Our direct work with communities has immediate impact and results, as communities are enabled to protect their reefs in partnership with global funders

OneReef's 4 existing Marine Conservation Agreements provide Micronesian communities with long-term financing to conserve and protect over 350,000 acres of pristine coral reef We have partnered with the governments of Palau and Federated States of Micronesia (FSM) to create sustainable financing and technical support for coral reef protection OneReef also provides enforcement infrastructure for communities to ensure demonstrable marine protection In 2015, we certified 26 conservation officers to implement marine management plans in Palau and provided training and funding for marine enforcement teams in Yap and Pohnpei, FSM, to prevent illegal fishing
