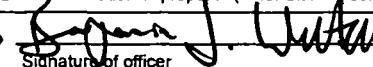

The major focus of the Bethel Gndiron Club for the year 2015 and the focus of its fundraising campaign was to fund the building of a Football Locker Room on the Campus of Bethel University, Arden Hills, MN. The commitment of the Bethel Gndiron Club for the building of the Football Locker Room was \$150,000 00, the commitment to be fully paid on or before December 31, 2015. The Bethel Gndiron Club did fulfill its commitment to the "Loker Room Campaign" \$121,364 72 of the \$150,000 00 commitment was contributed directly to the Bethel Gndiron Club, which amount was forwarded to Bethel University. The remaining amount of the commitment was funded directly to Bethel University by donors to the Bethel Gndiron Club, which funding was completed directly to Bethel University due to the types and forms of commitments and payments which Bethel Gndiron Club determined was expeditiously less cumbersome to handle through the greater range of fundraising capabilities of Bethel University. The Bethel Football Locker Room was named the "Frank H. Doten Bethel University Football Locker Room" in honor of Frank H.
