Vote Solar works to keep the way clear for Americans to produce their own solar power by ensuring customer access to net metering, helping regulators properly value distributed solar power, opposing unjustified rate fees, and otherwise establishing fair, solar-friendly rate structures. Vote Solar also works to solve the challenges posed by high penetrations of variable renewables on the grid. A dynamic, clean and distributed grid requires redesigning regulatory regimes to effectively manage distributed and variable generation while minimizing costs and maximizing environmental benefits.

Solar Market Drivers:

Under the Solar Market Drivers program Vote Solar advocates for policies that encourage utilities to increase the amount of renewable energy on the grid. These policies include incentives, tax credits, Renewable Portfolio Standards and procurement programs and resource planning processes.

Shared Solar & Low-Income Access:

The Shared Solar program works to establish the policies and programs necessary to allow renters and millions of other American homes, schools and businesses who do not have access to traditional solar on their roofs to choose clean energy for the first time. This program seeks to eliminate the barriers to participation in the solar economy for families and businesses who rent, those with low credit scores and those with shaded rooftops. Well-designed shared solar energy programs can connect these Americans with the clean energy they want for the first time. Shared solar is a way for consumers to subscribe to a local clean energy project and receive credit on their utility bills for their portion of the clean power produced.
