Reducing Methane from Oil and Gas Facilities CHERN supported Carbon Limits to overcome barriers reducing leaks and vents in oil and gas operations in Kazakhstan by working directly with companies and policy makers. Two leak detection and repair campaigns were performed one at a production site (EmbaMunaiGas) and one mostly at a distribution site (Intergas Central Asia). The teams detected and quantified methane and VOC emission sources. A number of easy-to-fix leaking components were repaired on the spot, showing the ease with which this climate and health pollutant could be avoided. Other viable cost-effective emissions reduction opportunities have been identified.

Post Earthquake Nepal The Nepal brick kiln industry was severely affected during the April 25 and May 10, 2015 earthquakes. Nearly all the 110 brick kilns in and around Kathmandu were either damaged or destroyed. The project was to use the window of time from when the earthquakes occurred to when the brick firing season began in winter 2016 to develop better brick kiln designs and provide brick entrepreneurs with support during building and operation. Immediately following the earthquake a team of Nepalese and Indian engineers, architects and brick experts worked intensively to produce guidelines to support reconstruction of improved kilns that are earthquake resistant, lower emitting, use less fuel and produce better bricks. Nine kilns are currently operating with the new designs.

4c (Code:) (Expenses \$ 97,595 including grants of \$ 51,000) (Revenue \$)
Brick kiln measurements in Asia The Climate and Clean Air Coalition project aimed at providing guidance for best practices for emissions and energy measurements at brick kilns, improved measurement instrumentation capacity, and field validation for both protocols and instruments. Additional goals allowed us to push the science and plausibility of instrumentation. Drafting, planning and construction occurred in 2015 in preparation for a 2016 winter field season.
