Through artistry and imagination, TheatreLAB creates unique theatrical experiences that spark a collaborative exchange of ideas between artist and audience. The TheatreLAB ensemble cultivates an environment that fosters emerging talent and challenges artistic norms through experimental devices on new and thrilling works.

TheatreLAB has chosen live performance as our artistic medium because of its immediacy, its immersiveness, and its inherent ability to build community through shared experience. In order to continue developing and expanding the Richmond Theatre audience-base, we believe that patrons should be continually offered high-quality performance art, and arts organizations should strive to produce events that appeal to audiences outside of their own. TheatreLAB produced six shows for 2015, each running for three to five weeks. TheatreLAB estimates that these six shows sold a total of 2,100 seats, of the estimated 3,000 available to sell.
