During 2015, the organization raised money and sent it to Haiti. The main uses of this money were for scholarships for students at a vocational school in Haiti and for equipment and agricultural goods for a family assistance program in Haiti. The organization also received and then donated a \$113,809 solar market garden to Zanmi Agrikol, a sister organization. The solar market garden uses solar power to pump water to a drip irrigation system, which allows farming on a 2.5 acre plot during the dry season. As a noncash contribution of equipment and services, the amount is not included in the \$310,122 of grants or \$385,222 of revenue.
