Journeys of Compassion: Impact Nations conducted four, twelve day missions trips in 2014. We took teams of about 20 volunteers the Philippines, Haiti, Nicaragua, and Uganda. On these trips, the teams helped in medical clinics, distributed about 300 Sawyer water filters, provided education in health and sanitation, and taught local pastors and leaders. In total, they administrated 12 days of medical clinics, led 6 days of pastors and leaders training, and provided water filters and sanitation training to approximately 500 individuals. They also led a total of 16 outdoor evangelism meetings, conducted door to door evangelism, and baptized new Christian believers.

Clean Water Initiatives: In Uganda, we installed a water tank and rain water collection system that will provide clean water for an estimated 500 people, we installed rain gutters on a school to collect rain water that will provide about 500 school children access to water at school, we we built a spring box to tap a natural spring that provides water for approximately 1000 people, and distributed 136 Sawyer water filters that will provide safe water for a conservative estimate of 1105 people. In Haiti, we distributed water filters and proved safe water for an estimated 1200 people. In the Philippines and Cambodia, we provided water filters for about 275 people.

Education & Training: We conducted conferences and seminars that encouraged and equipped individuals to participate in evangelism and to serve others at home and abroad. We administrated two conferences that were five days long each, plus led an estimated fifteen other weekend events at churches in Canada and the United States.

IV. a. (1) Benjamin Stewart is the son of Steve and Christina Stewart, who are officers of the charity. He was employed as the Chief Operating Officer of Impact Nations Canada since November 1, 2012. The board of directors decided to send him to the United States to open a 501c3 charity in February of 2014. During a board meeting, the board reviewed his resume and compared salaries for comparable positions. Steve and Christina Stewart excused themselves from the meeting, and the remainder of the board of directors unanimously voted to hire Benjamin at \$65,000 per year.

IV. a. (2) Holly Stewart is married to Benjamin Stewart and is the daughter-in-law of Steve and Christina Stewart (officers). Holly was employed as the bookkeeper and projects administrator for Impact Nations Canada. The board (with Steve and Christina Stewart absent) unanimously approved her employment in the new U.S. charity.
