Martha's Vineyard's vision of a respite foundation is desperately needed. Very few of us are financially stable enough to afford a lengthy stay at a hotel while their loved ones hopefully get better from an accident, sickness, or cancer treatments. A similar concept, "Ronald McDonald" houses, only take in a limited number of immediate family members provided their loved one is under the age of 21 years old. Martha's Vineyard has no age restriction. Martha's Vineyard has housed over 725 family members. Due to some very lengthy stays, we have provided numerous nights of lodging. All services have been provided at NO cost to any of these families.

In 2014, Martha's Vineyard engaged Chuck Godwin, CPA with Warr & Forester P.A., to file the Articles of Incorporation as well as advise us regarding tax exemption. As President of Martha's Vineyard, I was unaware the Form 1023 and Form 990 for 2014 and 2015 were not filed timely. We provided the information to our CPA, Mr. Godwin, and thought all forms were filed. We accept that the filings were not made.

During this time, in my personal life, my husband nearly died from a blood clot. He has had some other extreme health issues. My father passed away last year. Time literally got away from me to check on the filing status of the Form 1023. Martha's Vineyard was unaware the filings were not made timely. Martha's Vineyard upon discovery that the Form 1023 and Form 990 for 2014 and 2015 were not timely filed, immediately engaged Saltmarsh, Cleaveland & Gund, P.A. in Pensacola to prepare and file the required forms. Martha's Vineyard hereby requests, pursuant to Rev. Proc. 2014-11, that MARTHA'S VINEYARD FOUNDATION, INC. be granted retroactive tax exemption from the date of the filing of its Articles of Incorporation, January 14, 2014. Please, I beg of you to forgive my ignorance in not filing timely the Form 1023.
