Form 990, Part VI, Section B, Line 12c - The conflict of interest policy requires disclosure of possible conflicts to and during consideration of potential agreements involving interested parties. The policy also requires periodic statements from the members of the governing board affirming compliance.

Form 990, Part VI, Section C, Line 19 - Upon request
