In recent years, Congress has had record high disapproval ratings and record low productivity levels. If it is to recover its vitality and esteem, it must change significantly. Democracy Fund Voice funded an effort by the Congressional Institute to initiate the Congressional Reform Project (CRP). The CRP will provide a forum to discuss the formation of a Joint Committee on the Congress of Tomorrow with the authority to propose revisions to the rules, procedures, and structures of the Congress, as well as a history of congressional reform, and proposals to fix the legislature's problems.
