

Part III. Program Service Accomplishments

Primary Exempt Purpose. We are a grassroots organization working to protect Idaho's unique way of life by empowering citizens to improve the economic well-being of their communities by preserving family farms and ranches, supporting local, sustainable agriculture, developing small businesses and clean energy, and being responsible stewards of Idaho's water, land, air and natural resources.

Line 28. We worked to promote sustainable, local agriculture in many ways. Our staff and members worked to pass state administrative rules for cottage food producers that allow small-scale, home-processed foods to be sold directly to consumers with an appropriate regulatory system to ensure safety for consumers. Members of our Portneuf Resource Council chapter worked with the city of Pocatello to update the city's comprehensive plan, including developing a chapter for local and urban agriculture that supports local farmers.

We also worked with members of our Weiser River Resource Council chapter to establish and operate a farmers market in Weiser, Idaho.

Line 29. Our oil and gas work focused on educating Idaho citizens about the importance of making sure energy development in our state is done right, without polluting our water or leaving landowners and taxpayers with the cost of cleanup. We distributed free information, in print and online, about the impacts of development in other areas and protections that other states have adopted to protect their citizens and working landscapes. We also worked with members in Gem County to develop an oil and gas ordinance. We worked with the state of Idaho's Oil and Gas Conservation Commission to draft administrative rules for oil and gas permitting.

Line 30. We devoted considerable time and resources to organizing our chapters, the Portneuf Resource Council and the Weiser River Resource Council. Members of these chapters contribute to our statewide efforts as well as projects in their local communities. We also focused on growing our membership and expanding our reach.

Line 31. Other work included providing leadership development for our members, providing educational materials on the proposed Galloway Dam on the currently free-flowing Weiser River, and presenting on groundwater protection to the Bannock County Commissioners.
