THE SCHOLARSHIPS AWARDED BENEFITED INDIVIDUALS IN NINE STATES ACROSS THE US. PLEASE SEE SCHEDULE O FOR A CONTINUATION OF PROGRAM SERVICE ACCOMPLISHMENTS.
