



Part III, Primary Exempt Purpose

Our mission is to enable older residents of Central Seattle to age in their own homes and participate in an intergenerational community that shares knowledge, experience, and services with each other so living is easier and more joyful. We offer members a wide variety of services and other assistance, including health and in-home services, social, educational, and cultural activities, and community engagement -- all designed to foster belonging, security, and participation in the life of the community.

Part III, Line 28, Member Services

All of our services are related to acquiring and serving members, who (once they have joined) are entitled to both community-building activities (social, educational, other) and need-based services (provided by other members, volunteers, and referrals to recommended services). We have characterized these member services into three categories

1. Member Acquisition.

When Wider Horizons opened in June, 2015, we counted 70 people on our membership roster. This included a half-dozen people who had not yet paid their dues. It turned out that those individuals had decided to delay joining, so we removed them from the roster (and one member moved out of the area). Then, between mid-June and January 2016, we added another 13 members. Therefore, we now stand at 77 members. Our list of prospective members numbers about 130 with more jumping on every week. The rate of member acquisition is predicted to be at least two new members each month during 2016.

Between spring 2014 and the end of January 2016, we have held 28 prospective member gatherings, with a total estimated attendance of about 500. Most of these took place in the home of a member or friend; several in the common rooms of condos or apartments, and a few in other community venues.

2. Community-Building.

Community-building is the central principle of our village. We include our volunteers and the wider community in this effort and it is both woven into everything we do and can be teased out as follows from some of our accomplishments:

a. All members are assigned to a fellow-member interviewer. We developed a package of forms and trained about a dozen members to perform this important function. Now the interviewers have met an average of 4-6 members each, while each interviewed member has gotten to know at least one other member.

b. Data from most of the interviews, along with data from forms filled out by joining members, is entered in our Club Express database. These data reflect members' interests in activities, services, and volunteering as well as some personal data.

c. Four all-member meetings were held in 2015. These and our Open House at the beginning of June served to move prospective members into membership as well as built awareness and spirit among existing members. Attendance ranged from 25 to more than 100 and we've gotten rave reviews from those who attend. These typically involve a report of activities from the Executive Director, followed by Q & A, socializing, activities, and, of course, food. We expect to hold all-member meetings quarterly in 2016 at different community venues.

d. Members have formed 8 pods on the basis of geography and are carrying out "getting-to-know-you" activities in small groups. These include: a soup night dinner; getting together to watch Democratic debates; dinner at a local restaurant, and the like.

e. A member-driven Activities Work Group planned and carried out two all-member (and key volunteer) social events over the summer:

* An evening picnic at Volunteer Park attended by 25 individuals.

* A Meet & Greet hosted by our bank at its Capitol Hill branch had a similar attendance.

f. A group garage sale at Cal Anderson Park in August raised \$720 and also engaged members and people from the wider community.

And it provided an opportunity for members to de-clutter their homes.

g. During the holiday season, five members volunteered to host either a dinner or an Open House for members. These were extremely successful, though only about one-third of our members attended (though several attended multiple events).

h. Activity groups have formed and continue to form. We are holding classes. These groups and classes, as well as "one-off" spontaneous events, constitute our community engagement offerings: (1) Yoga series; (2) Practice of Health Intro; (3) Healthcare Advocacy Training; (4) Book club; (5) Warm for Winter knitting/crocheting group preparing hats and scarves for homeless folks; (6) Dinners, coffees, movie outings; (7) Magazine night; (8) One-off Gypsy Jazz night; (9) Gathering to watch the Democratic debate.
