PRIMARY GOAL FOR THIS PROJECT IS TO STUDY NGLY1 DEFICIENCY USING INDUCED PLURIPOTENT STEM CELLS (IPSC) AS A TOOL. IN THE PAST, THIS GROUP HAS DERIVED IPSC LINES FROM FIBROBLAST CELLS WITH DIFFERENT NGLY1 MUTATIONS. ONE OF OUR MAJOR GOALS IS TO BETTER UNDERSTAND THE EFFECT OF NGLY1 DEFICIENCY DURING DISEASE DEVELOPMENT, ESPECIALLY IN THE DELAYED NEURAL DEVELOPMENT.
