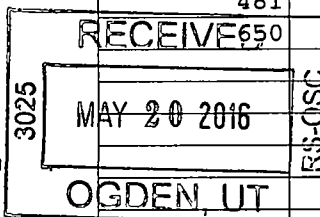

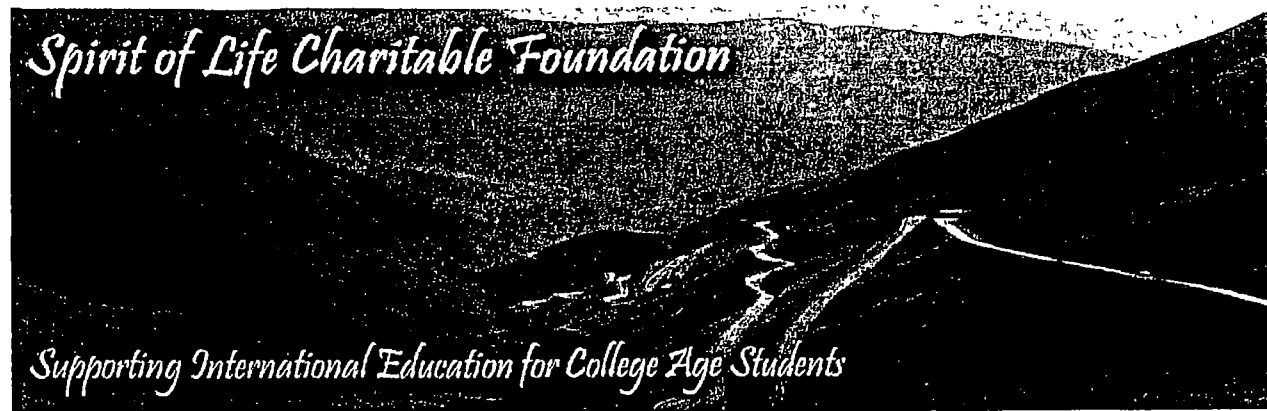

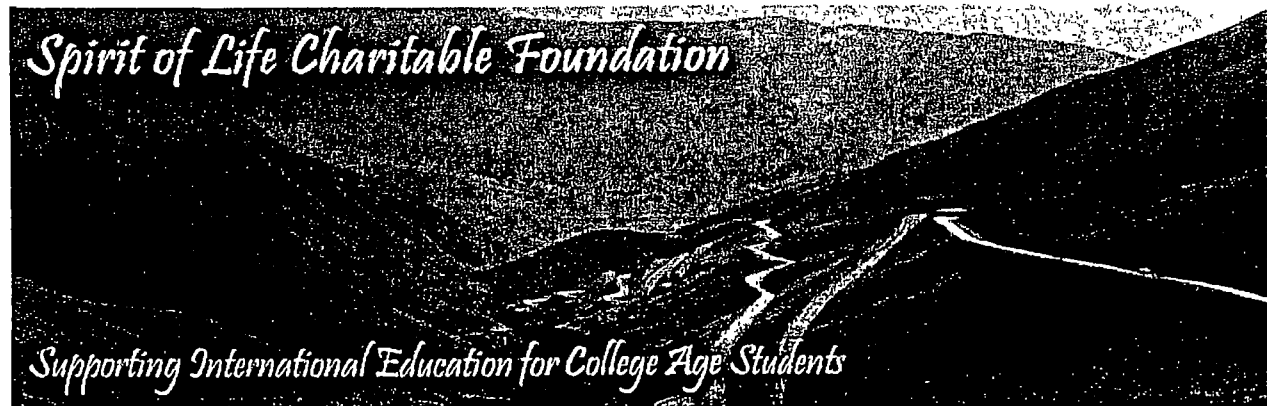
How the Foundation is Funded and Regulated
