MARY LANNING HEALTHCARE (MLH) PROVIDES HEALTHCARE SERVICES TO THE GENERAL PUBLIC AND OPERATES ROUTINE SERVICE BEDS, ICU BEDS, OUTPATIENT SERVICES, A HOME HEALTH PROGRAM, AND A SCHOOL OF NURSING. MLH TAKES ITS RESPONSIBILITIES FOR PROVIDING BENEFITS TO THE SURROUNDING COMMUNITIES SERIOUSLY. THIS IS DEMONSTRATED IN NUMEROUS WAYS. THE HOSPITAL ABSORBED OVER \$37 MILLION IN COSTS DURING 2015. OVER \$27 MILLION OF THAT AMOUNT RELATES TO CARE PROVIDED TO MEDICARE AND MEDICAID PATIENTS WITH AN ADDITIONAL \$3.1 MILLION IN CARE TO THE UNINSURED IN THE FORM OF CHARITY CARE. MUCH ATTENTION HAS BEEN PAID TO THE RESPONSIBILITIES OF TAX-EXEMPT ORGANIZATIONS. FROM THE INFORMATION SUMMARIZED HERE, IT IS CLEAR THAT THE CONTRIBUTIONS OF THE HOSPITAL FAR EXCEED FUNDS THAT WOULD BE GENERATED BY A CORPORATE TAX STRUCTURE.
