FUNDS WERE GRANTED FOR THE RECONSTRUCTION OF A HY-RAIL MOTOR CAR, AN AUTOMOBILE WHICH CAN DRIVE ON BOTH ROADS AND RAILROAD TRACKS. THIS PROJECT WILL RESTORE A CLASSIC 1956 PONTIAC CHIEFTAIN WAGON TO USE AS A HY-RAIL MOTOR CAR. THESE CARS ARE PART OF THE RAILROAD HISTORY OF THE NEVADA NORTHERN RAILWAY NATIONAL HISTORIC LANDMARK. THEY WERE USED FOR MAINTENANCE TASKS ALONG THE LINE. THE REFURBISHED CAR WILL BE USED TO INTERPRET THE HISTORY OF THE RAILWAY AND TO ENHANCE THE VISITOR EXPERIENCE, AS IT WILL PROVIDE A MEANS FOR SMALL GROUPS TO TOUR THE RAILWAY.

FUNDS WERE GRANTED TO THE WHITE PINE HISTORICAL RAILROAD FOUNDATION TO MAKE TWO PHYSICAL IMPROVEMENTS TO THE NEVADA NORTHERN RAILWAY NATIONAL HISTORIC LANDMARK. THE FIRST PROJECT WAS TO RETROFIT THE DEPOT PLATFORM IN ORDER TO OPEN UP A SECOND TRACK AND CREATE A SAFER LOADING ZONE FOR PASSENGERS. THE SECOND PROJECT WAS THE CONSTRUCTION OF A 27 X 27 SHELTER AREA (COVERED, BUT STILL OUTDOORS) IN THE PASSENGER PLAZA. BOTH PROJECTS WERE APPROVED BY THE NEVADA STATE HISTORIC PRESERVATION OFFICE.

CURRENTLY, THE TOWN OF DESERET HAS NO PUBLIC GATHERING SPACE. WORK ON THE BUILDING INCLUDED REPLACING THE FAILING ROOF AND TRUSSES, INSTALLING NEW SOFFITS AND FASCIA, AND INSTALLING A WHEELCHAIR RAMP. WORK ON THE BUILDING WAS APPROVED BY THE UTAH STATE HISTORIC PRESERVATION OFFICE PRIOR TO ANY CHANGES BEING MADE TO THE BUILDING.
