GodsKids.org has a strong reputation for accountability at the orphanage level and within its own corporate structure. GodsKids.org overhead is corporately sponsored regarding its operational expenses and donations are used directly for the orphanage and education programs in the field. Medical care is also provided. Mexico, Thailand, and the Philippines all received staff visits during 2015.
