Impact Chantable strives to increase charitable giving by offering donor advised funds. To leverage the impact of donor advised fund assets, Impact Chantable invests fund assets in select companies that have purposes and practices that are compatible with the organizations chantable goals. Impact Chantable hired a part-time executive director in the spring of 2015 with a part-time director of engagement joining in the fall. With these dedicated staff members, the organization began more significant work with donors and grew its donor advised fund assets. The organizations facilitated 148 grants to chanties in 2015, totaling close to \$80,000. Impact Chantable continued to develop its impact investment strategies, and made investments in publicly traded companies with strong environmental, social, and governance practices and outcomes.
