4a (Code: ) (Expenses \$ 1,931,666 including grants of \$ 1,108,750 ) (Revenue \$ ) Promoting Positive Christian Engagement: The mission of the Philos Project is to promote Christian Engagement in the Middle East. All our programs are designed to bring a Christian voice to the Middle East. Philos Leadership Institute and the Philos Leadership trips are only two such programs. Philos also has a campaign to support persecuted Christians in Iraq and Syria. In cooperation with other non-profits, we successfully lobbied the US State Department to issue a 2016 finding that the Islamic State in the Levant (ISIL) is committing genocide against Christians and other minorities. Moreover, in cooperation with two other organizations, we helped create Providence, a foreign policy journal from a Christian perspective whereby knowledgeable Christians submit articles on the Middle East and other foreign policy matters.

4b (Code: ) (Expenses \$ 383,364 including grants of \$ ) (Revenue \$ ) Philos Leadership Trips. The Philos Project created leadership trips to Israel for delegations of Christian leaders who have the potential to conduct Christian advocacy related to the Middle East. These trips serve to educate and inform leaders about the Middle East. They serve to fully educate and inform these leaders about the Middle East, and they also serve as a strong rapport building tool that facilitates the augmentation of our Philos network.

4c (Code: ) (Expenses \$ 309,570 including grants of \$ ) (Revenue \$ ) The Philos Leadership Institute (PLI): In 2015, the Philos Project created a yearly educational initiative that provides advanced educational training to 20 promising bright young Christian leaders who seek to eventually become employed in a field related to the Middle East. The seminar transforms these future leaders into skillful Christian advocates. In this program, we offer a fully paid educational excursion that includes two weeks in New York, and two weeks in Israel. We provide high level seminars on key topics related to Christian advocacy. We then track our graduates and attempt to guide them into suitable advocacy positions within and without our network of organizations.
