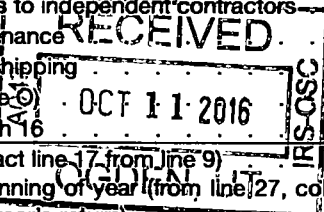



Statement of Program Service Accomplishments

Our Finding Forever Families program provides an introduction to the process of adoption through the state foster care system. Through 3 seminars, we have introduced hundreds to the opportunities abounding in adoption from foster care. Hosted and moderated by Let It Be Us and featuring adoption professionals involved in the foster care process along with parents who have adopted children from foster care, we have introduced many adults to the concept. Our events bring potential parents and adoption recruiters together in Illinois for the first time.

Working with the Illinois Center for Adoption and Permanency and the Department of Children and Family Services, we initiated the effort to increase the number of children in the Illinois Heart Gallery which is a photography and narrative exhibit featuring children available for adoption. This is a tool used by adoption recruiters to find permanent families for the over 3,000 children waiting to be adopted in Illinois. In addition, our social media presence allows us to target permanent families and help the vulnerable population of kids of foster care.

Our Educational Mentorship Program is designed to help older children who will most likely never be adopted. It leads the way to produce high school graduates and college students by training volunteers to mentor and tutor those kids living in group home without parents or foster care. Our recruitment and training program has certified 30 Educational Mentors since its inception.
