Asociación SERES offers programs in environmental education and youth leadership development. In 2015, Asociación SERES ran 26 multi-day sustainability leadership programs for 631 young leaders. Asociación SERES was awarded the UNESCO ESD Prize on Education for Sustainable Development in 2015. Asociación SERES was also named as a finalist in the Equator Prize, 2015.**

Asociación SERES - the sole grant recipient for 2015 - maintains accounting records (on cash basis) documenting its expenditure for youth training and educational programs and other miscellaneous program expenses. These records are maintained by a licensed licensed Guatemalan accountant, and submitted monthly to the Guatemalan SAT as required by the Guatemalan laws and regulations. During 2015, Asociación SERES provided 26 multi-day training workshops to 631 youth from disadvantaged and at-risk communities in the relating to a registered not-for-profit charitable association. Every three months, detailed financial reports are provided to the SERES Global President for review. Copies of all of Asociación SERES' transactions are stored in hard copy and electronically on Asociación SERES' servers and are available for review by SERES Global upon request.
