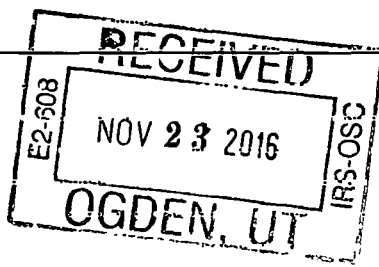

During their senior year, the SSP alumni serve as peer mentors to the next class of SSP students while continuing their service work with the foundation.

The SSP strives to educate students about leadership, civic engagement, and community involvement. Funds for the program are obtained through program sponsorships, special events, and grants.

Each November, RNF mobilizes 250 volunteers to feed approximately 1,000 individuals a Thanksgiving dinner in one of the most disadvantaged areas of Hillsborough County. The foundation partners with other organizations in the Tampa Bay area to help serve the individuals and distribute boxes of food to take home afterwards. Families identified by the University Area Community Development Corporation are invited to attend the dinner, which is traditionally held on Tuesday evening the week before Thanksgiving. Upon their arrival, families are greeted by volunteers, shown to a table, and served an already plated meal by volunteers. While eating, families enjoy a performance donated by a local band, and after dinner the families are able to utilize a photo booth to take family portraits that are printed out on the spot for them to take home. provided with a box of fresh meat, produce, beverages, and nonperishable food items from the mobile pantry provided by Feeding America Tampa Bay.
