THE ORGANIZATION PROMOTED THE DEVELOPMENT OF AFFORDABLE HOUSING IN PENNSYLVANIA BY HAVING MONTHLY MEMBERSHIP MEETINGS TO DISCUSS LEGISLATIVE ISSUES AFFECTING HOUSING AND BY PARTICIPATING IN THE ANNUAL HOUSING ALLIANCE HOMES WITHIN REACH CONFERENCE. THE ORGANIZATION ALSO WORKED WITH THE PENNSYLVANIA HOUSING FINANCE AGENCY RELATED TO DEVELOPMENT ISSUES RELATED TO PROVIDING AFFORDABLE HOUSING IN PENNSYLVANIA.
