Live and Learn guides each participant along their journey, including basic skill-building, career track training, job search strategy, post-placement challenges and adjustments, and housing transition. At 2015 year-end, Live and Learn had enrolled 77 participants in the following Career Tracks: 10 in Accelerated Career Track, 7 in Healthcare careers, 3 in Basic Skill Building, and 57 in Child Development Associate. Additionally, we worked with 53 women who were in progress as Year 2 Live and Learn clients, and a further 26 clients via our partnership with Fresh Start. Live and Learn is pleased to report we have positively impacted more than 155 participants in 2015.
