In compliance with 42 C.F.R. Section 301.6652-1(f) showing of reasonable cause for failure to file a Form 990-PF for the year 2014, Frank McGrath, president of the board of trustees of the Robert H. Spitz Foundation, submits the following Statement under penalties of perjury:

Robert H. Spitz Foundation had no trustees who had accepted their position as trustees and did not conduct any activities during the year 2014.

The Foundation was recognized as a 501(c) (3) private foundation by the Internal Revenue Service on April 3, 2015 with a retroactive effective date of January 16, 2014, the date of the death of Robert H. Spitz, who bequeathed funds to establish the Foundation in his will. As noted in the Foundation's original Form 1023 filing, no funds were transferred from Mr. Spitz's estate to the Foundation during 2014 and the Foundation did not conduct any activities.

While Mr. Spitz's will named the initial trustees of the Foundation, the named trustees did not begin to consider Foundation activities until 2015 and did formally accept appointment until early 2016. The Foundation is still not funded and has conducted no activities other than having trustees meet to discuss its future activities. It anticipates receiving its first distribution of assets from the estate in mid-2016, at which time it will begin its grantmaking activities.

The Trustees are timely filing a Form 990-PF for 2015, although they have no financial activity to report. In an abundance of caution, they are filing a Form 990-PF for the year 2014

simultaneously with filing the Form 990-PF for 2015 although the Foundation did not function in any way during 2014.

I, Frank McGrath, President of the Board of Trustees, declare under penalties of perjury, that I am authorized to sign this Statement of Reasonable Cause on behalf of the Robert H. Spitz Foundation, and I further declare that I have examined this Statement of Reasonable Cause, including the written explanation of all the facts of the claim for reasonable cause, and to the best of my knowledge and belief, this request is true, correct, and complete.
