THE BEACH FAMILY FOUNDATION WAS FORMED ON 12/29/14 AND THE APPROVAL FOR TAX EXEMPT STATUS WAS APPROVED BY THE IRS AND WAS EFFECTIVE AS OF THIS DATE.

PURSUANT TO IRC CODE 507(B), THE BEACH FAMILY FOUNDATION QUALIFIES AS A TRANSFEREE FOUNDATION AND AS SUCH SHALL NOT BE TREATED AS A NEWLY CREATED ORGANIZATION. THE TAX ATTRIBUTES OF THE ROSS AND MARIANNA BEACH FOUNDATION UNDER IRC SECTION 4940(E) CARRIES OVER TO THE BEACH FAMILY FOUNDATION. THE BEACH FAMILY FOUNDATION HAS REPORTED \$35,751 OF UNDISTRIBUTED INCOME (THEIR 50% SHARE FROM THE ROSS AND MARIANNA BEACH FOUNDATION) AND USED 1% TO COMPUTE THE EXCISE TAX ON INVESTMENT INCOME.
