In 2015 we worked with the World Business Council for Sustainability Development (WBCSD) to create a decision support tool that enables major corporations to better understand water scarcity risk and environmentally sound solutions in key basins where they operate. We created this tool with seven members of WBCSD: Dow Chemical, Monsanto, PepsiCo, Kering, Arcadis, Veolia and CH2M. The geospatial, cloud based tool identifies the best available sites for restoring wetlands to the benefit of better water storage and environmental consequences. The initial version of the tool was completed in December 2015 and focused on Dow Chemical operation in the Brazos River basin in Texas. The tool was very well received and enabled corporations to see for the first time how they could improve water quantity throughout the entire watershed.
