USJAN collaborated with other nonprofits, criminal justice advocates, and law enforcement to engage in both grassroots and direct lobbying efforts at the federal and state level on criminal justice issues. USJAN assisted with drafting legislation, testified before state legislatures, and participated in press conferences to highlight proposed reforms. USJAN highlighted state successes for members of Congress in support of federal criminal justice reform. USJAN was also active in Ohio, Michigan, and Pennsylvania on state specific criminal justice reform issues.

Education: U.S. Justice Action Network (USJAN) hosted various summits and forums to educate the public and policy leaders on the need for criminal justice reform. USJAN staff also collaborated with other organizations by speaking at various events and participating in summits highlighting criminal justice issues.
