THE ORGANIZATION IS A NEWLY FORMED COMMUNITY DEVELOPMENT CORPORATION FOUNDED TO DEVELOP AND SUPPORT PROJECTS IN THE URBAN NEIGHBORHOODS LOCATED IN THE WESTERN PORTION OF LOUISVILLE, KENTUCKY ("WEST LOUISVILLE"). THESE NEIGHBORHOODS INCLUDE THE ALGONQUIN, CALIFORNIA, CHICKASAW, PARK DU VALLE, PARK HILL, PARKLAND, PORTLAND, RUSSELL AND SHAWNEE NEIGHBORHOODS OF WEST LOUISVILLE. THE ORGANIZATION AIMS TO STIMULATE ECONOMIC DEVELOPMENT AND COMMUNITY REVITALIZATION IN WEST LOUISVILLE, WITH A PRIMARY FOCUS ON THE BUILT ENVIRONMENT. BY FOCUSING ON LAND USE, INFRASTRUCTURE NEEDS, URBAN DESIGN AND AN OVERALL IMPROVED "SENSE OF PLACE," ONE WEST'S GOAL IS TO BRING A SHARED PROSPERITY BACK TO WEST LOUISVILLE, WHICH IN TURNS LIFTS THE ENTIRE LOUISVILLE COMMUNITY. ONE WEST WAS CONCEIVED LESS THAN A YEAR AGO BY A TEAM OF PARTICIPANTS IN THE LEADERSHIP LOUISVILLE CENTER'S 2014 BINGHAM FELLOWS CLASS, WHO, WORKING AS VOLUNTEERS, HAVE BUILT A SOLID FOUNDATION FOR THIS NEW ENTITY. THE ORGANIZATION'S INITIAL STEPS ARE EXPECTED TO BE: (I) CONTINUE TO CONDUCT COMMUNITY ENGAGEMENT TOURS IN WEST LOUISVILLE TO SOLICIT INPUT FOR POTENTIAL REDEVELOPMENT PROJECTS AND COMMUNITY NEEDS, (II) DEVELOP A COMPREHENSIVE STRATEGIC PLAN THAT OUTLINES SPECIFIC SHORT- AND LONG-TERM GOALS AND PRIORITIES FOR THE NEXT FIVE YEARS, (III) HIRE AN EXECUTIVE DIRECTOR WHO HAS THE KNOWLEDGE AND EXPERTISE TO ACHIEVE SUCCESS, (IV) DEVELOP AND EXECUTE A FUNDRAISING CAMPAIGN TO SECURE THE CAPITAL NECESSARY TO ACHIEVE THE GOALS SET OUT IN THE STRATEGIC PLAN, (V) SELECT INITIAL PROJECTS TO SUPPORT, INCLUDING EXPLORING THE POSSIBILITY OF AN APPLICATION FOR NEW MARKET TAX CREDITS FOR WEST LOUISVILLE, THE FORMATION OF AN INVESTMENT POOL TO SUPPORT PROJECTS FOR ECONOMIC DEVELOPMENT, AND SUPPORTING OR UNDERTAKING REAL ESTATE DEVELOPMENT AND URBAN PLANNING EFFORTS TO IMPROVE THE WEST LOUISVILLE STREETScape AND COMMERCIAL CORRIDORS, TO COMBAT BLIGHT AND FURTHER COMMUNITY DETERIORATION. THE DECLINE OF WEST LOUISVILLE HAS OCCURRED OVER DECADES, AND CONTINUES, DESPITE SOME SUCCESSFUL EFFORTS TO EFFECT CHANGE AND MANY FAILED EFFORTS. MANY STUDIES DOCUMENT THAT WEST LOUISVILLE IS AN ECONOMICALLY DEPRESSED AREA. MOST WEST LOUISVILLE NEIGHBORHOODS ARE LOCATED IN HUD QUALIFIED CENSUS TRACTS, WHICH INDICATES A POVERTY RATE OF AT LEAST 25% TO 50% OR MORE OF HOUSEHOLDS WITH INCOMES BELOW 60% OF THE AREA MEDIAN INCOME. WEST LOUISVILLE NEIGHBORHOODS HAVE HIGHER CONCENTRATIONS OF MINORITY POPULATIONS, POVERTY, HIGHER VIOLENT CRIME RATES, HIGHER POVERTY RATES AND LOWER EDUCATIONAL ATTAINMENT RATES THAN ANY OTHER REGION OF LOUISVILLE. IN JANUARY 2015, HUD RECOGNIZED THE ECONOMIC AND COMMUNITY DISTRESS OF THE RUSSELL NEIGHBORHOOD AND BEECHER TERRACE COMMUNITY OF WEST LOUISVILLE BY AWARDING THE LOUISVILLE METRO HOUSING AUTHORITY A HUD CHOICE NEIGHBORHOOD PLANNING GRANT. THE ORGANIZATION WILL WORK TO STIMULATE ECONOMIC DEVELOPMENT IN AN AREA THAT HAS BEEN HIT BY THE LACK OF CAPITAL FOR DEVELOPMENT, SOCIAL UNREST AND INSTABILITY AND THE DEPRESSED MARKET OF NEIGHBORHOODS LOCATED IN QUALIFIED CENSUS TRACTS. ONEWEST'S ACTIVITIES ARE INTENDED TO RELIEVE POVERTY, LESSEN NEIGHBORHOOD TENSIONS AND COMBAT FURTHER COMMUNITY DETERIORATION. THE ORGANIZATION (1) WILL TARGET ITS ASSISTANCE TO AID THE ECONOMICALLY DEPRESSED AND BLIGHTED AREA OF WEST LOUISVILLE, (2) WILL BENEFIT DISADVANTAGED GROUPS, SUCH AS MINORITIES AND THOSE OF LOWER INCOME, WHO INHABIT WEST LOUISVILLE, AND (3) WILL HELP STIMULATE ECONOMIC AND COMMUNITY DEVELOPMENT ACTIVITY IN WEST LOUISVILLE, WHICH EXPERIENCES NEGLECT FROM THE CONVENTIONAL FINANCIAL AND BUSINESS MARKETS.
