Give Backs: This is the direct "presents" support to children suffering from pediatric cancer (while in hospital) as well as their siblings and parents, if applicable. Give Back events include: Christmas Gift Packs (18), Christmas in July (12), Easter Baskets (20), Father's Day and Mother's Day Baskets (50), Halloween and Thanksgiving Bags, Guard Christmas Baskets, Hero Baskets (15), Pizza and Craft Outreach and Assistance on a weekly basis.

Cancer Awareness and Fundraising for a Cure: This is direct, community events that raise money to support the research and cure of pediatric cancers. 2015 Events included: CureSearch Hike, which raised \$11,000 in funds directly to CureSearch, Cookies for Kids Cancer, where gold bows were made and sold - raising \$920 and St Jude's Blume Hematology & Oncology T-Shirt fundraiser, which generated \$134.16 for research.

4c (Code) (Expenses \$ 4,288 including grants of \$) (Revenue \$)

Direct Hero Assistance: This is direct family support for children with pediatric cancer, similar to "Make A Wish". In this program, the patient and their family is provided with support to grant a specific dream of a child with terminal cancer. It can involve covering transportation costs, hotel, some meals and tickets to the event. This is done on a case-by-case basis as funds are available. We also tap into connections within the community where the child's dream is to be realized and help coordinate the event in conjunction with Harlan's Heroes. In 2015, six families were supported, including two trips, which occurred just weeks before the patient passed away.
