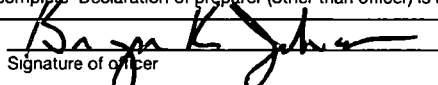

In 2015, Endeavor Louisville reviewed approximately 130 companies, completed approximately 91 mentor reviews, with 6 companies presenting at a 3 local selection panel, and prepared 3 companies to present at 2 international selection panels, resulting in 2 companies and 3 entrepreneurs selected as Endeavor Entrepreneurs. During 2015 Endeavor Board Members and Mentors donated approximately 150 hours of support to entrepreneurs. Endeavor Louisville released a research report on the state of greater Louisville - Southern Indiana's entrepreneur eco-system. Endeavor Louisville provided to its Endeavor Entrepreneurs mentorship and other services, including support during the fundraising process, and access to partnerships, new growth markets, and business education programming.

However, income from certain activities not directly related to the Organization's tax exempt purpose may be subject to taxation as unrelated business income. Management does not believe the Organization has unrelated business income for the period from February 13, 2015 to December 31, 2015. The Organization files an informational return with the U.S. government.
