Nearly eight out of ten FSGC clients live near, at, or below the Federal poverty line. In some FSGC programs that number reaches nine out of ten.

Staff include psychologists, reading specialists and learning disabilities specialists who treat individuals age two through adult with learning problems including dyslexia, ADHD, Asperger's Syndrome and other learning disabilities. They also perform kindergarten readiness assessments. Family Service & Guidance Center also offers an APA (American Psychological Association) accredited pre-doctoral internship in clinical psychology. We also offer a pre-doctoral internship in marriage and family therapy as well as masters and bachelors level internships/practicums in psychology, social work and marriage and family therapy. These year-long programs offer an intensive training experience in a range of clinical skills.
