Three watershed restoration and protection programs, two above the federal reservoir of Perry Lake and Tuttle Creek Lake, that provided cost-share assistance to 65 landowners that addressed pollutants that affect the water quality of the watersheds. Pollutants include sediments, nutrients, bacteria, livestock waste which affects public drinking water supplies in the lakes. These programs assist with extending the storage capacity of the lakes and enhances the quality of public drinking water.

- 4b (Code:) (Expenses \$ 196,259 including grants of \$) (Revenue \$)
The Delaware River Streambank Restoration Program addresses the issues of streambank erosion that produces sediment and other nutrients that are deposited into Perry Lake, a federal reservoir that provides public drinking water and flood control for the population in eastern Kansas. The lake is silting up with sediments from farmland and streambank erosion. The program constructed four streambank restoration sites by constructing a flatter slope to reduce erosion and establishing vegetation and trees to further provide protection and re-establish a riparian forest along the river.

- 4c (Code:) (Expenses \$ 120,549 including grants of \$ 1,150) (Revenue \$)
Regional economic development and small business development program provide training, technical assistance, and business planning and financing to entrepreneurs starting small businesses and existing business owners wanting to expand their business. Over 100 people were assisted and 30 jobs created. The program includes the Glacial Hills Food Center which is a shared-use commercial kitchen food processing facility that provides space for food entrepreneurs to develop and process food products for their businesses. Three businesses used the facility to process food products that were sold through farmer's markets and retail stores. These businesses provide employment and create sales tax from sales of products to consumers.
