TENANTS TO HOMEOWNERS(TTH) ACQUIRES PROPERTIES FOR THE PURPOSE OF REHABILITATING, RENTING, AND SELLING HOMES IN TRUST TO LOW OR MODERATE INCOME RESIDENTS IN THE LAWRENCE COMMUNITY. DURING 2015, 4 NEW HOMES WERE PUT INTO TRUST. 9 FAMILIES RESOLD THEIR HOMES AND WERE ABLE TO USE THEIR EQUITY IN THEIR SOLD HOME TO PURCHASE LARGER HOMES IN THE MARKET. THIS ALLOWED 13 NEW FAMILIES TO PURCHASE HOMES THROUGH TTH ASSISTANCE. FURTHER, TTH HELD ITS FUNDRAISING EVENT - "EVERY HOME CAN BE A CASTLE". THIS AUCTION WAS AGAIN HUGE SUCCESS THAT RAISED OVER 11,000 OF CONTRIBUTIONS. TTH ALSO CONTINUED TO PROVIDE FREE PUBLIC EDUCATION ON MORTGAGE FINANCING, THE HOME BUYING PROCESS, AND HOME MAINTENANCE THROUGH PUBLIC WORKSHOPS AND INDIVIDUAL HOUSING.
