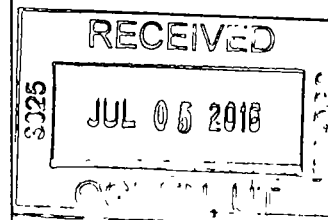

Government Advocacy: AIA NM advocated for state-level legislation to require home-rule entities to use Qualification Based Selection for
contracting services of architects, engineers and surveyors. It advocated for adoption of legislation to allow the use of Public Private
Partnerships for state infrastructure acquisitions. The organization also advocated on the federal level for energy efficiency standards for
federal buildings.

Support of AIA NM Architects: Biennial Design and Honow Awards were celebrated. AIA NM members submitted 25 projects for juried
awards and eight received awards for exceptional design work. AIA NM member firm was awarded the Architect Firm of the Year Award and
a member received the NM Architects Medal for dedication to service to architecture and the profession. Extensive publicity was generated
to promote the benefits of architects and architecture to the general public.
