MUSIC EDUCATION AND COMMUNITY OUTREACH:

The ASCAP Foundation is dedicated to nurturing the music talent of tomorrow by developing and supporting educational programs that provide effective learning opportunities consistent with our mission to students of all ages. The ASCAP Foundation has provided funding to sponsor 42 Music Education and / or Music Development programs and one community outreach program throughout the year with the goal of enhancing and promoting music education and providing the community with access to music and its history. These 43 programs include 20 programs that received \$5,000 or more and 23 programs that received less than \$5,000.

SCHOLARSHIPS, FELLOWSHIPS, AWARDS AND COMPOSER PROGRAMS:

The ASCAP Foundation scholarship programs seek to ensure that opportunities for the study of music and instruments, songwriting, music composition, the business of music and related areas are available to students at all levels by providing Scholarships and Fellowships to 70 recipients ranging from \$500 - \$10,000. The ASCAP Foundation provides awards to emerging composers and writers consisting of cash awards to 113 recipients of composer and / or lyricist programs. These awards range from \$200 - \$10,000. Of these 113 awards, 2 were for \$10,000, 9 were for \$5,000 and the remaining 102 were less than \$5,000.

TALENT DEVELOPMENT AND COMMUNITY OUTREACH:

The ASCAP Foundation Talent Development and Community Outreach programs provide aid and encouragement to music creators world wide who are in various stages of their careers including Workshops (18); Commissions and / or Commissioning programs (2) and sponsorship of talent development programs. (26). By providing professional opportunities to emerging composers, lyricists and songwriters, The ASCAP Foundation supports their careers and promotes their works.
