New Faculty Scholars Support:

Since the inception of the New Faculty Scholars Award in 1988, more than 100 STFM members have received these awards. The award is intended to provide STFM members who are in their first 2 years as full time faculty and who exhibit outstanding leadership potential the opportunity to attend the STFM Annual Spring Conference. This introduction to over \$1,000 STFM members leads to community building activities such as participation in groups and membership on committee and task forces.

Three to seven scholarships are awarded annually.
