Community Champions Network Through Community Champions Network, which operates across the U S and Canada, NACAC worked with 40 local leaders to create and enhance support groups, trained 30 parent group leaders, supported the launch of two foster/adoptive parent associations, and helped several communities with their efforts to enhance available post-adoption services Community Champions Network also provided training to 35 youth leaders and staff about how to create and expand youth support and advocacy networks At the annual NACAC conference, we provided additional leadership and advocacy training to 26 youth and staff supporters During the year, we helped 10 groups either create or expand their youth support services

Public Education and Conference The NACAC conference in Long Beach, California served more than 800 adoptive parents, adoption professionals, and others committed to achieving permanence for children in foster care Participants attended about 90 educational sessions where they learned how to better support children with disabilities and other challenges, recruit and prepare permanent families for kids, replicate model programs, change the system to improve outcomes for vulnerable children and their families, and much more NACAC offered training in person and through webinarsto thousands of adoption community members during 2015 on topics such as parent group development, effective support services for families, transracial parenting, core issues in adoption, and adoption competence NACAC also helped hundreds of prospective adopters find the information the need to navigate the adoption process, and the NACAC website provides in-depth information on adoption issues to tens of thousands of site visitors each year

Advocates for Families First NACAC, in collaboration with the National Foster Parent Association and Generations United, continued to advocate to ensure that children are placed in families, rather than group care, whenever possible During 2015, staff met with 24 Congressional staff to raise awareness about policy issues that affect kinship, foster, and adoptive families and partnered with advocates in Maine, Ohio, and Louisiana to advance local advocacy efforts on behalf of adoptive, foster, and kinship care families We also offered training to more than 300 support organization leaders through webinars and conference presentations, and provided technical assistance to help enhance the advocacy or support services of 12 adoption, foster, or kinship care-serving organizations Advocates for Families First also maintained and updated a resource-rich website visited by thousands of individuals, and shared information with more than 1,500 members of the child welfare field about key issues related to ensuring that children have families and families have the support they need
