General explanation attachment	Part III line 4 - Statement of Program Accomplishments Tucson Meet Yourself Festival 2015 Tucson Meet Yourself is an annual celebration of the living traditional arts of Southern Arizonas and Northern Mexicos diverse ethnic and folk communities Each October, the three-day event features hundreds of artisans, home cooks, dancers, musicians and special exhibits that celebrate and honor beauty in all its diverse, informal, and everyday forms In 2015 we served over 100,000 people attending the festival We also hosted an exhibit entitled 100 Years of Anthropology in partnership with the University of Arizona and Department of Anthropology Additionally we supported local and national cultural performers in an Artist Showcase and individual support through a Global Foodways Fellowship Master-Apprentice Program 2015 The SFA Master-Apprentice Award is designed to support the teaching/learning relationship between traditional artists and their apprentices The goal of this award is to strengthen the transmission of community-based traditions throughout the Southwestern United States The award supports a master artist or tradition bearer who has identified a qualified apprentice (or group of apprentices), to engage in a relationship that includes intensive learning, one-on-one mentorship and hands-on experience in his/her traditional artistic practice In 2015 we made the following four Master-Apprentice Awards to Master Artists, Mari Kaneta, Zarco Guerrero, Ron Carlos, and Felipe Molina to work with their Apprentices over the course of the 2015 year Continuum Multicultural Practices in Grief and End of Life 2015 The Southwest Folklife Alliances Continuum project shares cultural knowledge about traditions, expressions, and practices associated with end of life, grief, mourning and death in Southern Arizonas folk, ethnic, occupational, faith-based and alternative communities In 2014-2015 the project engaged 27 Citizen Folklorists in ethnographic fieldwork to map and document local traditions associated with death and dying It published a Journal including interviews, photos, and citizen reports of place-based death-related traditions The project also hosted a FREE public half day symposium attended by over 100 individuals, hosting discussions and presentations on diverse local cultural expressions and national research associated with culture and end of life Oro Valley Meet Yourself 2015 The Town of Oro Valley invited the Southwest Folklife Alliance to present the first annual Oro Valley Meet Yourself Festival on March 21 & 22, 2015 The festival showcased the local cultural diversity and folklife of Oro Valley The Southwest Folklife Alliance conducted an informal cultural asset map of the region to inform its programming Thank you to Anthropologist, Katie OBrien for conducting the fieldwork that supported this program There were over 1,500 people who attending this FREE event Ethnographic Fieldschools 2015 Southwest Folklife Alliance Ethnographic Fieldschools offer training on the basic skills of cultural analysis and documentation, using the toolbox of ethnography as practiced by anthropologists and folklorists The Fieldschool includes, hands-on involvement and field activities about traditional foods, ways of life, and artistic expressions of everyday life, visits with artisans and tradition-bearers in their own workshops and homes, coaching and dedicated time to hone place-based writing skills and basic documentation techniques in addition to strategies to publish on blogs, newsletters and community publications In 2015 we conducted a Fieldschool in the Rio Sonora region of Mexico with 15 life-long learners and students
