The Gardiner Public Library hires and oversees a Librarian who is an employee of the City of Gardiner. The Librarian is an ex-officio, non-voting member of the Board of Directors of the Association. The Librarian attends meetings of the Association's Board and provides information and input to the decisions made by the Board. The 11 independent members of the Board of Directors of the Association vote on all of its operational and financial decisions.
