- We provided transitional housing to 207 male individuals during the year

- 122 were on Parole from the Hawaii Parole Authorities

- 37 were on probation from Hawaii Adult Probation Authorities

- 25 were on Federal Probation/Parole

- 39 were walk-in

- 6 supervised release

- 1 Vet

Our current success rate is 64% transitioned from our home back into the community

Vocational Training. A department within our organization has been formed to provide basic labor jobs along with training. This department has been named "MOKA TECH". This program started on October 1, 2013 and is still in the process of evolving into more then bacis labor skill training. We are tyying to partner with others to provide higher skilled jobs and training. In 2016 our goal is to have at least one of the partners in place. But currently we have secured contract to remove all items from hotel quest rooms that are being renovated on the island of Oahu. This items are then transported and stored. We then sell this items to cover all costs associated with this work. All profits are used to further this organization.
