FOUNDED IN CAIRO IN 2011, NEBNY FOUNDATION AIMS TO IMPACT THE LIVES OF THOUSANDS OF RESIDENTS IN MANSHET NASSER, CAIRO'S LARGEST SLUM AREA, KNOWN OTHERWISE AS GARBAGE CITY. THIS 1.2 MILLION PERSON NEIGHBORHOOD SUFFERS FROM MANY ILLS, INCLUDING CHRONIC UNEMPLOYMENT (78 PERCENT), HIGHEST INFANT MORTALITY RATE (5 PERCENT BEFORE THE AGE OF 5), SHORTEST LIFE EXPECTANCY (33 YEARS) AND THE LOWEST QUALITY OF EDUCATION (60 PERCENT OF SIXTH GRADE STUDENTS ARE ILLITERATE).
