In addition to e-mail, telephone calls, and hosting special events (including small farm seminars), educational and informational newsletters were provided to each of the 6000 members.

The BCFB participates in many local agricultural events that offer opportunities for educational outreach. These activities include some specific focus on urban schools, in order to promote agriculture programs throughout the county. In addition, support of the mobile ag lab has helped in excess of 2000 students annually better understand local food sources.
