Initial certification requires a trainee to meet extensive educational, professional and general requirements and to satisfactorily complete an examination on the Standard for Control of Gas Hazards on Vessels as well as all applicable U.S. Coast Guard and OSHA rules and regulations. Certification qualifies the chemist to determine whether construction, alteration or repair of all types of marine vessels can be safely undertaken.

Supported the administration of paper and electronic certificates required to be issued by a certified marine chemist to authorize work in spaces that may have contained hazardous materials.

Approximately 92 marine chemists served.
