Program 1 Movement Activist Apprenticeship ProgramThis year is the MAAP programs thirtieth anniversary The Movement Activist Apprenticeship Program (MAAP) is a pioneer national organizer training program, training activists of color in the skills needed to run campaigns that address issues affecting people of color across the country As the oldest training program exclusively for people of color, MAAP has served to build a vibrant network of activists bonded by a life changing experience This achievement has directly served Equal Voices goal of building strong cross-issue networks to share knowledge, organize constituencies of low-income families and pursue policy advocacy campaigns for change On the cusp of its 30th anniversary, MAAP has been redesigned to deepen its impact for both host sites and apprentices Beginning in 2014, CTWO located MAAP within consolidated city-based projects, with more apprentices working together in the same cities in order to deepen their organizing experience, make a greater impact on the local or regional political terrain, and build stronger ties among apprentices Moreover, host sites were asked to commit to at least two years of participation to strengthen the relationship between host sites and MAAP, and to offer graduates opportunities to return to previous sites as lead organizers These structural changes to the program not only expose apprentices to a broader range of dynamics of a campaign, such as participating in long-term strategy sessions and escalation tactics, but also serve to increase the potential for real campaign wins By assigning more apprentices in fewer host sites, MAAP seeks to increase the capacity of member-led organizations and amplify the collective voice of families and grantees, so that they can influence public discourse and public policy Program 2 Community Action TrainingsCTWO provides 3-day intensive organizing skills and leadership training to various member led organizations, through our Community Action Trainings (CAT) in Pittsburgh Not only does CAT provide hands-on knowledge of grassroots community organizing within communities of color, it also creates spaces for people of color to build relationships with each other, further expanding the network of activists of color working towards racial justice in the area Since it was launched 20 years ago, CTWO has trained over 4,000 individuals across the country Participants of our Community Action Trainings (CAT) learn how to door-knock and other forms of contact work as a tool for recruiting and mobilizing constituents, participate in campaign development and actions, learn grassroots fundraising techniques, debate approaches to social change as well as develop strategies that link the legacy of organizing in communities of color with today's fight for social justice Program 3 Pittsburgh, PAOur third Project is a locally based coalition initiative in Pittsburgh, which seeks to bring about change through successful policy reforms driven by low-income families According to the Urban Institutes recent study on racial equity across the US, Pittsburgh scores an overall F, landing in the 85th spot compared to other metropolitan regions
