The Treasury Regulations provide that a collateral assignment split-dollar arrangement is an arrangement in which the Organization is deemed to have made a loan to the employee whose life is insured in connection with the arrangement in an amount equal to the life insurance premiums advanced by the Organization to the insurer. However, it is uncertain whether such a deemed loan is also treated as a loan for purposes of Section 4958(c)(3)(A)(i) of the Code. If the deemed loan is treated by the IRS as a true loan, then Code Section 4958(c)(3)(A)(i) could possibly classify the deemed loan as constituting an excess benefit transaction. The IRS has not provided any specific guidance concerning whether a deemed loan in connection with a collateral assignment split-dollar employee benefit arrangement utilized by a supporting organization would give rise to an excess benefit transaction. However, the IRS recently revised the instructions to Schedule L of Form 990 to require disclosure of payments made pursuant to a split-dollar life insurance arrangement that are treated as loans under Regulations section 1.7872-15 and the instructions refer to such payments and other loans and advances as loans. In light of the lack of specific definitive guidance and the breadth of these instructions, the Organization has elected to discontinue the use of collateral assignment split-dollar arrangements with its employees who the Organization considers to be disqualified individuals.
