ON A THREE-YEAR REVIEW CYCLE, THE COMPENSATION RANGE FOR EACH POSITION IN THE ORGANIZATION IS REVIEWED. AN ARRAY OF DATA IS RESEARCHED AND CITED IN ORDER TO ENSURE THAT THE COMPENSATION FOR EMPLOYEES IS IN LINE WITH COMPARABLE POSITIONS AT OTHER LIKE ORGANIZATIONS. DATA INCLUDES SURVEYS FROM OTHER NOT-FOR-PROFIT ENTITIES, US DEPARTMENT OF LABOR, HEALTHCARE SURVEYS, SURVEYS SPECIFIC TO ORGAN AND TISSUE DONOR AGENCIES, HOSPITALS IN THE METROPOLITAN AREA, AND NATIONAL SURVEY DATA WHICH IS CONVERTED TO THE ORGANIZATION'S GEOGRAPHIC REGION. MINUTES OF THE P & C COMMITTEE ARE MAINTAINED AND PROVIDED TO THE BOARD OF DIRECTORS, AND BOARD MINUTES ARE MAINTAINED. IN ADDITION TO THIS DATA ANALYSIS AND LEVELS OF FORMAL REVIEW, THE DATA AND THE PROCESS ARE REVIEWED BY THE ACCREDITATION BODY (AOPO) THAT PROMULGATES STANDARDS FOR ORGAN DONOR AGENCIES.
